APPLICATIONS THAT MAKE DIGITAL ACCESS SAFE IN OUR SCHOOL

To ensure that our students have safe and responsible access to the digital world, we offer various applications. These applications support students' learning while ensuring they stay safe online.

Username and Password Management

Each student is provided with a username and password to access the school system and CIS accounts. Students are encouraged to keep their passwords confidential and not share them with anyone. They are also advised to change their passwords regularly and use strong passwords.

School Email Accounts

Each student is given a school email account with the format ad.soyad@stu.acischools.k12.tr. This email account can be used for communication with teachers, submitting assignments, and accessing school resources.

Secure Internet Connection

At the beginning of the school year, students' tablets are registered in the school system by their Wi-Fi MAC addresses, ensuring secure internet access. This way, students can only connect to the school network with authorized devices, reducing the risk of encountering unwanted content while browsing the internet.

Microsoft Teams and Google Classroom

Platforms like Microsoft Teams and Google Classroom allow students to communicate with teachers and each other, share assignments, and participate in online classes. Students can access these platforms securely using their school email addresses.



Access to Office Applications

Students can access Office 365 with their school email addresses and use applications like Word, Excel, PowerPoint, and more.

Academic Integrity - Use of Turnitin

To promote academic integrity and prevent plagiarism, we use Turnitin, a text similarity detection software. Students can submit their assignments and projects to Turnitin to reduce the risk of plagiarism.

Child Protection Policy
